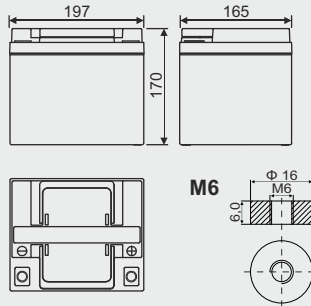

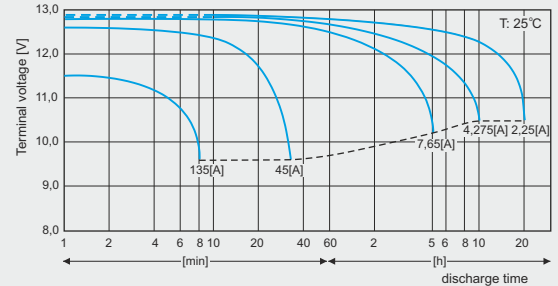

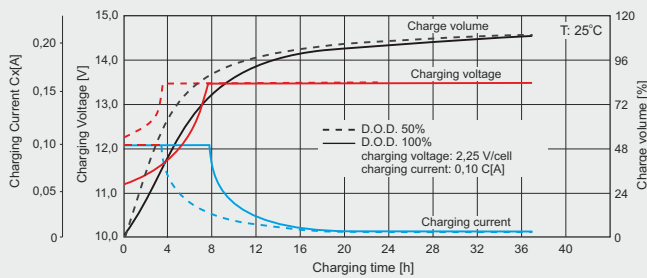

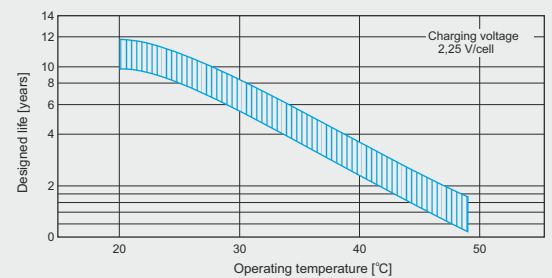

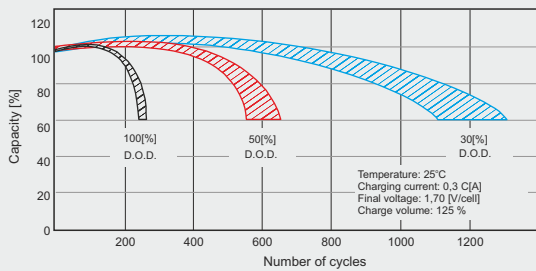

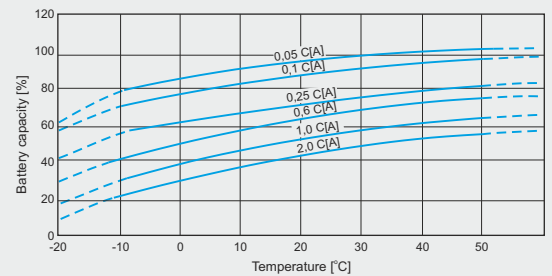

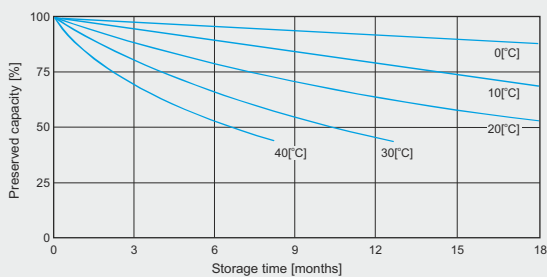
CYCLIC LIFE
